Sir/Madam,

Pawan Hans Limited is a Govt. of India Enterprises under the Administrative control of Ministry of Civil Aviation, Government of India. The Company was established mainly to provide helicopter support services to meet the requirements of the petroleum sector/Non-Petroleum Sector including ONGC, operate scheduled/non-scheduled helicopter services in inaccessible areas and difficult terrains, provide intra-city transportation and operate tourist charters.

The Company has an operational fleet of 42 helicopters consisting of 17 nos. AS365 Dauphin N, 14 nos. SA365 Dauphin N3, 3 nos. Mi-172, 3 nos. Bell 206 L4, 3 nos. Bell 407 and 2 nos. AS350 B3 helicopters.

The Company's equity capital is held by the Government of India (51%) and Oil & Natural Gas Corporation Limited (ONGC) (49%). The Company is managed by Board of Directors and the Chairman & Managing Director is the chief executive. While the Company's registered office is in New Delhi and Corporate Office at Noida. It has Regional offices at Mumbai, Delhi and Guwahati.

Accordingly, quotation of premium amount is invited for Personal Accident (Aviation) unnamed Policy for Regular and Contractual : 20 nos. of Pilots, Flight Engineers and Flight Attendants for sum assured of Rs. 40 Lacs each person for death while flying or on ground for operation in support for internal law enforcement operations and passengers services operations in disturbed area in **Agartala, Bhubneshwar, Gadchiroli, Manipur and Jammu & Kashmir** for renewal from 29.11.2018.

The insurance coverage is for death while flying or on ground for 24 hours PA cover against all accident including all non-flying risks and aviation accidents including also terrorism, in support of Police/ paramilitary operations (including insertion/evacuation of such personnel), Passenger services in disturbed area, Earthquake, Flood, Tsunami etc. The policy will also cover all landing and taking off from unlicensed landing areas.

These crew members are properly manifested while they are flying in support of such operations and passenger services and record of deployment of such crew members on these bases are available at respective bases.

In case of any death claim within the meaning of this policy, the medical reports and postmortem reports as would be made available by certified doctor or hospitals authorized to conduct and issue such medical report or Postmortem reports shall be accepted by Insurance company.

The Insurance Company and the Insured can cancel this policy at any time by giving 30 days notice. The insurance company will return to PHL pro-rata portion of premium for unexpired period.

During the policy period the name of bases may be changed and any addition and deletion of bases during the policy period shall be payable / receivable on pro-rata basis.

It is also to inform that these Pilots, Flight Engineers and Flight Attendants (Regular and contractual) are also covered under named PA (Aircrew) policy for Sum Assured of Rs. 1 crore each person issued by M/s. The Oriental Insurance Company Ltd and this insurance coverage of Rs. 40 Lacs each person is an additional coverage over and above insurance coverage of Rs. 1 crore each person referred above.

Hence, Insurance Company shall pay the compensation/ claim amount in respect of any claim hereunder if the insured person is also entitled to benefit under any other personal Accident including Aviation Accident Policy taken by PHL or/ and Crew Members in his personal capacity and the insured person shall be entitled for benefit under all such policies i.e. all Policies taken by the Pawan Hans Ltd and the Policy taken by the insured person and it shall not be subject to any condition of insurance company.

It is also to inform that there is "NO CLAIM" under the aforesaid policy during the policy period 2013-14, 2014-15, 2015-16, 2016-17 and 29.11.2017 to till date.

The prequalification to quote the premium is as under which should be submitted in separate envelope:-

- a. Copy of IRDA Certificate of Registration or document evidencing renewal of IRDA certificate of registration for year 2018.
- b. Three years experience in aviation insurance includes both fixed wings and rotary wings business (supporting documents has to be attached).
- c. The copies of Group Personal Accident policies at least one copy for each year for the last 3 years to be submitted by bidder.

The bidder who will fulfill the above criteria will qualify for opening of price bid. The Price bid should be submitted in separate sealed envelope. Both the separate envelope of prequalification documents and Price bid should be contained in big envelope addressed to undersigned.

We shall be grateful to kindly submit the bid for renewal of aforesaid policy before 02.00 PM on 12.11.2018 to undersigned at address given below in a sealed envelope in respect of Regular and Contractual : 20 nos. of Pilots, Flight Engineers and Flight Attendants for sum assured of Rs. 40 Lacs each person for death while flying or on ground for operation in support for internal law enforcement operations and passengers services operations in disturbed area in Agartala, Bhubneshwar, Gadchiroli, Manipur and Jammu & Kashmir for renewal from 29.11.2018.
